# Collaboration

- Collaborative leadership team and process **(a)**

Travel required **(i)**
- Collaborate with consultant (and ODE) **(c)**

# Program Design, Implementation, and Improvement

- Design (or revise) blueprints that are research-based **(g)**
- Participate in scheduled grant meetings and trainings. Travel required **(i)**

# Use of Funds
