One testing opportunity per school year. Students taking OAKS Paper/Pencil, Braille, or Large Print should not be given access to OAKS Online.
- I)** English-only, English-Spanish, and English-Russian formats are available.

- J)** Students at the High School level are only allowed one writing test opportunity either during the winter or spring window. Beginning in 2012, 12th graders only may test in both windows. No extensions for the writing window or ship date will be granted.
- K)** Writing prompts available in English and Spanish
- L)** Districts must provide the opportunity for all 10th grade students to take the PSAT/NMSQT® except in districts with waiver.
- M)** If the postmark deadline is missed, students will be counted as nonparticipants
