

# 2015-2016 Special Education Report



April 2017

Dear Parents and Community Members,

The Oregon Department of Education is proud to issue the eleventh annual special education report. Reported indicators and targets correspond to the information in the State Performance Plan (SPP) for Special Education that is required by the United States Department of Education.

Oregon has a seamless system of services for children with disabilities from birth through age five that is operated by the Oregon Department of Education (ODE). ODE contracts with nine Education Service Districts (ESDs) across the state to provide early intervention/early childhood special education (EI/ECSE) services in 35 local programs. This system includes Part C early intervention (EI) for children birth to age three and Part B early childhood special education (ECSE) for children age three to kindergarten age, which is age five in Oregon. Children who are age five by September 1st are eligible for public school with special education services provided by the local school district.

As Oregon schools and districts continue to face many challenges, educators remain committed to providing the highest quality education for Oregon students. This report is not meant to tell you everything about your district, but it offers a starting point for discussions about where improvement might be needed and for celebrating successes in education for Oregon's children.
