Programs and Cross System Integration

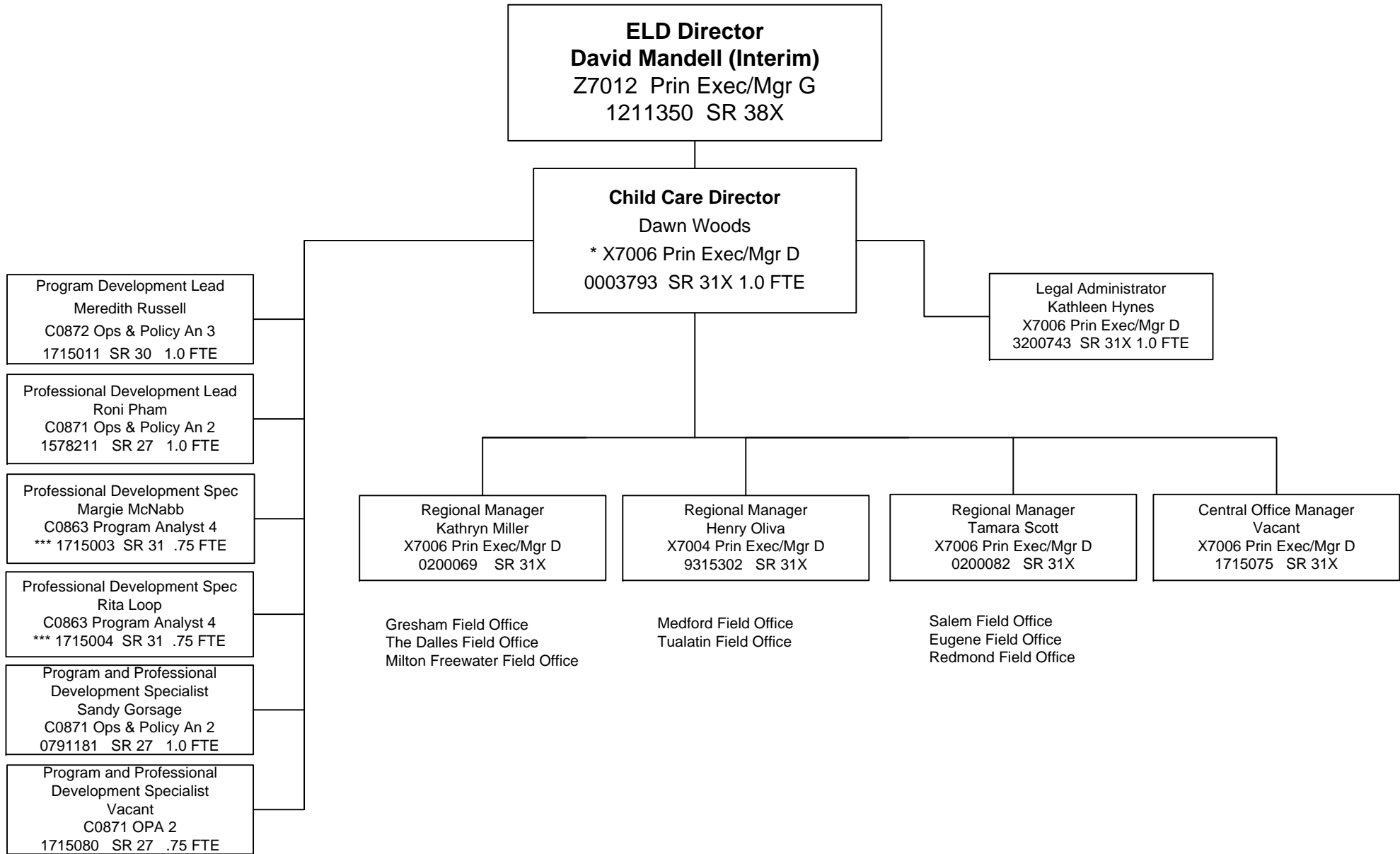
