TO: Sponsors of the Commodity Food Distribution Program

RE: Sunland Peanut Butter Recall

Action Required

The Oregon Department of Education Child Nutrition Programs (ODE CNP) received important information from the U.S. Food and Drug Administration concerning the Sunland Peanut Butter recall, which is pertinent to Sponsors of the Commodity Food Distribution Program.

According to our records, 66 Sponsors received Sunland Peanut Butter in September 2012. Only a few of the sponsors used the Peanut Butter in the school cafeteria. Sunland Peanut Butter must not be distributed or served. Please set these cases aside. ODE CNP will provide additional information on how to handle this recalled product as more information becomes available from USDA.

Sponsors that used the Peanut Butter should notify parents of the recall and, if possible, the dates or date range when the peanut butter was served. Parents should also be made aware of the symptoms of salmonella infection.

If any students that consumed this recalled peanut butter are having symptoms of illness, they should be referred to their health care provider for evaluation and their school district should be notified. Common symptoms may include diarrhea, fever, abdominal cramps, and headache, within 8 to 72 hours of consumption. Most healthy people recover within a few days without specific treatment.

Sponsors should also take steps to notify their local health department concerning the recall.

Sponsors must immediately notify Oregon Department of Education, Food Distribution Program if an outbreak or documented illness occurs. This information will be reported to USDA.
